

SHOW CAR PARTICIPANTS RULES & REGULATIONS:

The Iola Car Show has developed the following rules for the Show Car area.

Failure to comply with these rules may result in immediate ejection from the show grounds without any refund of fees.

1. The title will be used to verify the vehicle year. Vehicles newer than 1995 will not be allowed in the Show Car area, unless pre-approved by the Show Car Director.
2. No primer paint or rust areas will be allowed. Vehicles classified as Modified are the only exception to this rule.
3. **Designated Unloading Area:** Trailered show vehicles will enter Gate #4 and take the first left to the unloading area. Truck & trailers will exit through Gate #5 and proceed to **Show Car Trailer Parking** across from Gate #6. Additional truck & trailer parking can be found adjacent to the Car Corral (Follow Hwy J. to Gate 18). There will be no loading/unloading in the show car area between 8:00 a.m. - 6:00 p.m. Cars needing to enter/leave during these hours will need to drive on/off the grounds.
4. **NO "For Sale" signs may be displayed on or in a vehicle.** If the owner is not present to remove the sign, then the vehicle will be towed. Those wishing to sell a vehicle must register for a Car Corral space.
5. Show Car owners must check with the tower for overnight parking instructions. Cars improperly parked overnight will be towed into the correct position.
6. No camping in the Show Car area.
7. No food of any type, beverage, water, or ice may be sold, donated, or given free with purchase.
8. Political displays of any kind are not allowed, including but not limited to, signs, banners, for sale items or exhibits.
9. All tents rented must be obtained through the Iola Car Show's exclusive tent supplier- Charnecke Tents, 715-341-6886. Those who own tents/membrane structures – (shade canopy/tent/umbrella/etc.) may erect them using CAUTION, carefully considering the matter of; obstructions, location, weather, wind exposure, access, exit and anchoring stability. Tents/membrane structures must be adequately roped, braced, and anchored to withstand the elements of weather and prevent against collapsing. Owners will be solely responsible for any damage or injuries caused by the tents/membrane structures due to weather or any other unforeseen accidents. Items must be labeled with the owner's name, address, and phone number.
10. **Carts with an official permit may be operated during normal show hours (6:00 a.m. – 6:00 p.m.) within the boundaries of the designated path only. If the cart is found in any other location, during these hours, its permit will be revoked.**
11. Apart from rule #10 above, the only motorized vehicles allowed on the grounds are three or four-wheeled electric one passenger vehicles (mobility carts). Golf carts and bicycles are allowed in the Swap Meet and Car Corral, between 6:00 p.m. and 11:00 p.m., and the campground between 7:00 p.m. and 11:00 p.m. If you are caught abusing this policy, the privilege & vehicle will be revoked. All other vehicles motorized or non-motorized, including skateboards, are not allowed.
12. No pets allowed.
13. Recycling: Please recycle aluminum, glass and plastic in the cages/ bins provided. Place cardboard next to the receptacles.
14. No open fires or fireworks in show car at any time.
15. No paging except in cases of emergencies.
16. No radios, stereos, TV, loudspeakers, etc.
17. Use of obscene language, gestures and disorderly conduct is prohibited.
18. NO firearms, crossbows, BB guns, or any other weapons are allowed. Neither may they be sold.
19. No refunds will be given after June 1.
20. Iola Old Car Show, Inc. assumes no responsibility for any damage or loss by fire, theft, weather, or any other course whatsoever.
