

## OFFICIAL 50-50 RAFFLE RULES

**DESCRIPTION:** 50-50 Raffle is a raffle whereby tickets are sold at the Iola Old Car Show, Inc. (IOCS) Grounds beginning at 6:00 a.m. CST. Ticket sales end at 2:00 p.m. CST, each day. Tickets are sold for: (5) tickets for \$5.00, (10) tickets for \$10.00, and (20) tickets for \$20. The winning ticket will be drawn at approximately 4:00 p.m. CST and will be announced from the Iola Car Show Tower. The lucky winner must be present to win and can collect half of the proceeds from total raffle ticket sales. The other half goes to the Iola Old Car Show, Inc. The winner must present the winning ticket by 6:00 p.m. CST that same day or shall forfeit the winnings.

- 1. ELIGIBILITY:** This raffle is only open to legal residents of the fifty United States and District of Columbia who are 18 years of age or older as of the date of entry. Employees of IOCS and their immediate families and household members are not eligible to enter or win. Subject to all applicable Federal, State and Local laws. Void where prohibited.
- 2. HOW TO ENTER:** The raffle begins at 6:00 a.m. CST each day and ends when the tickets are collected following the 2:00 p.m. deadline. All ticket entries must be received by the end of the raffle period. The drawing will take place at or about 4:00 p.m. each day and will be announced from the Iola Car Show Tower shortly after, with winners collecting by 6:00 p.m. that same day. These times are subject to change without notice pending changes in show schedule and flow. By participating in this raffle, you agree to follow these contest rules. By accepting a prize, you give IOCS permission (except where prohibited) to use your name, likeness and statements for publicity purposes without additional compensation including display of your name and image.
- 3. DRAWING:** The prize winner will be selected in a random drawing from among all eligible entries received. The odds of winning for each entry are 1/total number of entries received. The drawing will be held at or about 4:00 p.m. each day and conducted by IOCS Staff whose decision is final and binding. The winning ticket number will be posted at the Iola Car Show Tower. If the winner fails to collect within reasonable time as posted within these rules, they are subject to disqualification and forfeiture of winnings. Only one ticket will be drawn.
- 4. PRIZES:** (a) 50% of the total raffle ticket revenue collected (b) Taxes will be the sole responsibility of the winner, (c) The cash prize will be paid to the winner by check within 30 days of the date the prize is claimed. (Tax withholdings may apply), (d) The designated 50-50 raffle ticket is the only valid receipt for claiming a prize. Winner must also present valid photo ID.
- 5. ODDS:** The odds of winning the prize are 1/the total number of entries.
- 6. GENERAL RULES:** All entries and prize claims become the property of IOCS and will not be returned. Released parties (as defined below) assume no responsibility for lost, late, stolen, delayed, damaged, misdirected, undelivered, illegible, incomplete or postage-due entries, prize claims or mail. Except where prohibited, by accepting a prize, winners consent to the use by IOCS and its designees of their names and/or photographs for advertising and publicity purposes in any and all media now or hereafter known throughout the world in perpetuity without limitation and without additional compensation, notification or permission. By participating in this raffle, each entrant accepts and agrees (i) to be bound by these Official Rules and the decisions of IOCS staff, which shall be final and binding in all respects, and (ii) to release IOCS, and its parents, subsidiaries, affiliates and advertising/promotion agencies, and the respective directors, officers, employees and agencies of the foregoing (collectively, the "released parties") from any and all liability of any injuries, losses or damages of any kind caused by participating in this raffle or resulting from acceptance, or use/misuse of the prize. Entries generated by script, macro or other automated means will be void. IOCS reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the raffle, violates the Official Rules, or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE IS A VIOLATION OF THE CONTEST RULES AND OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, IOCS RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW.
- 7. DISPUTES:** Each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or in connection with this raffle, or any prizes awarded, shall be resolved individually, without resorting to any form of class action, and any judicial proceedings shall take place in a federal or state court within the state of Wisconsin.; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this raffle, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and IOCS in connection with the raffle, shall be governed by, and construed in accordance with the laws of the State of Wisconsin, without giving effect to any choice of law or conflict of law, rules or provisions (whether of the State of Wisconsin, or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than the State of Wisconsin. IN NO EVENT SHALL IOCS OR ITS RELATED ENTITIES BE LIABLE TO ANY ENTRANT OR WINNER FOR DAMAGES THAT EXCEED THE VALUE OF THE PRIZE TO BE AWARDED TO ANY INDIVIDUAL ENTRANT IN THIS RAFFLE.
